I will provide a jacket for my child in case the temperature drops during the camp day. Failure to do so, will result in an additional fee. I understand that my child is required to wear a helmet when mounted on horseback, and will provide a helmet, or ask Royal Legend to provide one during camp. If medical attention is needed for my child, I agree to Royal Legend seeking medical help, and of me being responsible for any medical charges incurred. I agree to pay \$250.00 per child, per session of camp.
